Snow Camp 2017 Info Sheet

February 24th – 26th

General Info:

We will be leaving Friday, February 24th to travel to Circle C Ranch in Delevan, NY (www.circlecranch.org). This trip takes approximately three hours and will include one stop for dinner in Bradford, PA. If you are going as a counselor, you need to be at the First Church of God in New Bethlehem at 12:00PM on Friday so that we can load the luggage. If you are a student at any school other than Redbank, you will need to be at the First Church of God in New Bethlehem by 12:30PM. We will pick up Redbank students at the following times:

Redbank Valley Int. School	12:45PM
Redbank Valley High School	1:00PM

Here is a checklist of things you need to do before we leave:

- 1. If you have Facebook (or have a parent that does), please join our Facebook group called Snow Camp 2017. We will be doing all room assignments and sending out all announcements through that group. The group page can be found here: https://www.facebook.com/groups/307710342942520/
- 2. Each student may choose 2 students that they wish to room with. However, if you have a group of 6 to 7 students already picked out, they you have a full cabin. Room sign-ups will take place the night of the Snow Camp meeting on February 4th at 6PM at the First Church of God in New Bethlehem. If you are unable to attend this meeting, you can send your requests into the Snow Camp 2017 group page after that date. We will try our best to get you the room we want, but with over 150 kids, we cannot please everyone. Remember, you are only in your cabins to sleep.
- 3. Take in a permission slip signed by a parent to the school office stating that you will be getting out of school at the appropriate time on Friday and will be picked up by Pastor Doug Henry or Pastor Randy Hopper.
- 4. Every student and leader must fill out the Individual Registration Form and the Snow Camp permission form in its entirety. The parental signature granting permission for this trip should be notarized due to Circle C Camp insurance purposes. We will try to have a notary at the Snow Camp meeting in case you need to notorize your form (they may charge a small fee).
- 5. Check the packing list to make sure you have everything you need. If you are taking medication with you, please have a parent contact Pastor Doug Henry (Boys) or Angie Rearick (Girls) with that information.
- 6. You can bring your luggage to the First Church of God in New Bethlehem on Thursday night from 6PM to 9PM or Friday morning from 9AM to 12PM. Please try to limit luggage to one big bag, one carry on, and your bedding. You may also bring it that day but you will have to keep it with you through the school day.
- 7. You must be at least 12 years of age at the time of the trip to go to Snow Camp.

Packing List:

Here is a list of all the things that you should need for your Snow Camp trip. Due to the large number of kids going, we are limiting you to one big bag and one carry-on bag.

- Snow clothes. Chances are, it will be very cold and we will get snow in this area of New York. Even if there is no snow, the snow machine will be making snow for the tubing hill. Make sure you have the proper gloves, hats, coats, pants, and boots to stay warm.
- You will probably want some tennis shoes to wear when playing inside, climbing the wall, and in the Lasertron Arena. You may also want to bring shower or bathroom shoes. At the very least, you will want to bring two pairs of boots/shoes in case one gets wet.
- Clothing to wear for Friday, Saturday, and Sunday. We will be going to several church services, but you do not need dress clothes. You will also want to bring clothes to sleep in. Also, make sure you follow camp rules by not wearing any clothing that advertises Rock or Country bands, alcohol or tobacco companies, or clothing that is too revealing.
- Bedding. You may bring either a sleeping bag or a sheet and blanket to sleep on as well as a pillow. Bedding does not count against your luggage allotment. You are welcome to bring stuffed animals to sleep with, but they must fit in your allotted luggage amount (1 big bag, 1 carry-on)
- Decorations and outfits. You may want to bring things to decorate your cabin with (Christmas lights, posters, etc.). You may also want to bring costumes for the tubing contest and other events. All decorations must fit in in your luggage.
- Toiletries. You will need to bring everything you need to get ready in the morning. You will need to bring your own towels, wash cloths, soap, shampoo, deodorant, tooth brushes, toothpaste, etc. Please keep electric beautifying machines to a minimum and realize that it still needs to fit in your 2 pieces of luggage.

Non-Packing List:

Circle C and I have some rules about what you do not need to bring with you.

- Cell phones. You are welcome to bring your cell phone with you on the trip, but you should not need it. My rule is that once we get to camp, if I see it, it belongs to me unless it is an emergency use I have approved.
- You are not allowed to bring any MP3 players, video game systems, or the like. That is a camp rule. My rule is that if I see it, it's mine. Their rule is if they see it, you go home. You will not need that stuff to have a good time. You may bring it on the trip, but it must stay on the bus. We are not responsible for watching over your stuff all weekend.
- You may not bring any alcohol, tobacco, or drugs with you. I know I don't have to say that with this group, but I just need to let you know the camp policy.

Money Info:

The cost of the trip is \$80. Checks can be made payable to *Leatherwood Church Youth* unless your Youth leader has told you otherwise. This will include your meals, transportation and lodging. However, scholarships are available if you need help with paying the \$80. You will not need a lot of money to have a good time on this trip, but you will need to bring some. You could easily get by with \$20 and I would suggest sending no more than \$50. Here is what you need to know to decide what you should send:

- We will be eating at dinner on the way to Circle C by stopping at a church. This meal is included in the price.
- We will stop on the way back to use bathrooms, get fuel, and stretch our legs. There is a convenience store where we stop, so if you want to get snacks, that is on you. This stop will not be at mealtime.
- There is a snack shop with pop, drinks, and other snacks at the campground. They do feed us well, so this is purely up to you how much money you want to spend here.
- There is also a souvenir shop at the camp. If you feel that you have to have a Circle C Ranch shirt, DVD, or souvenir, you will need money for there.
